Project educates Kazakhstani women on monitoring medical abortion outcomes

The dBest multilevel pregnancy test (MLPT) is available in Kazakhstan for purchase. Until recently, though, most providers and women were unaware that it could be used to monitor medical abortion outcomes. With support from a special safe abortion-themed round of the Innovation Fund, Gynuity developed and tested written instructions and a short <u>instructional video</u> for women and providers on the use of MLPTs for medical abortion follow-up in Russian Kazakh. Gynuity partnered with the local IPPF affiliate, Kazakhstan Association for Sexual and Reproductive Health (KMPA), and other advocates to inform providers, representatives of the Ministry of Health, and other policymakers about the MLPT and these new resources. Current in-country efforts focus on the registration of an MLPT for sale in pharmacies, which will increase access to this novel technology.

Medical abortion providers routinely require women to return one or two weeks after taking abortifacient drugs to confirm pregnancy termination. Ultrasound, pelvic examination, or serum pregnancy tests are costly and may be inconvenient, particularly for women who live far away or have competing commitments, and they must be performed by specially trained personnel.

EuroNGOs hear that funding gap could reach cumulative \$1.1 bn

As the number of users of contraception grows, so too does the volume of supplies required for user consumption. The Coalition's recent Global Contraceptive Commodity Gap Analysis (CGA) costed current and projected user consumption volumes, and compared those costs to the amount currently spent on contraceptive supplies across 135 low- and middle-income (LMI) countries.

At the recent EuroNGOs 2017 conference Nina Miller, CGA project lead, shared key findings on the growing gap between the cost of contraceptive supplies and the funding available to purchase them. She revealed that the gap between the consumption cost and all spending on supplies is projected to reach a cumulative \$1.175 billion for the years 2016 through 2020. She was speaking in a panel co-hosted by the Coalition, titled "SRHR without contraceptives? Supplies financing in an increasingly challenging funding environment" with speakers from the Mozambican Association for Family Development, PAI, and UNFPA. Read more

Coalition's Safe Abortion work stream takes shape

Earlier this year, the Executive Committee decided that the Coalition's work in safe abortion commodities should gain momentum under the umbrella of a dedicated workstream. In September, the NURHT Caucus became home to a new-work stream focusing on safe abortion commodities. Participants from foundations, donor agencies, technical organizations and civil society attended an inaugural teleconference which refined the agenda for the upcoming meeting in Dakar. Key players come on board Latin American initiative

Last month, SupplyInsider's lead story shed light on a new two-part initiative designed to bridge a largely sidelined Latin America with world advances in contraceptive commodity security, and assist rural health authorities in four countries to estimate more accurately the cost of distributing RH supplies and advocate for increased resources for commodities. Since then, the Coalition's ForoLAC has brought together high-level key players such as UNFPA-LACRO, Peru's Ministry of Health and CENARES (Peru's National Procurement Agency). They have developed work-plans, and have taken on board a costing tool to be used with rural health authorities. A situational analysis is underway to gather market intelligence from LAC countries on price and volume of contraceptives procured, actual demand and unmet need, and other key market indicators. The findings will inform the organization of two "encuentros" or special learning sessions, which the Coalition and UNFPA-LACRO will co-host with national governments, manufacturers and procurers.
