URGENT: DRUG RECALL

Depo-Provera[®] (medroxyprogesterone acetate injectable suspension, USP) 150 mg/ mL Contraceptive IM Suspension

Dear Customer,

Pfizer Inc is recalling the below referenced lots of **Depo-Provera[®] 150 mg/mL Contraceptive IM Suspension**. Pfizer Inc voluntarily initiated this recall due to a potential compromise of sterility assurance during manufacture of the referenced lots. All sterility test results for these Depo-Provera[®] lots were found to be acceptable. Please note that risk of adverse health consequences from the administration of the below mentioned lots of Depo-Provera[®] 150 mg/mL Contraceptive IM Suspension has been assessed to be low.


The recall of **Depo-Provera[®] 150 mg/mL Contraceptive IM Suspension** is being conducted to the **Hospital/Healthcare Centre level**.

Our records indicate that you may have received shipment of the affected lots between **October 2009** and **January 2010**. Please check your stock immediately against the table on the next page. If you have any of the affected product in your inventory; please stop distribution and promptly indicate the amount of product in your possession. If you have further distributed this lot to other accounts, please conduct a sub-recall and communicate this recall information to those accounts immediately. Please request that they immediately cease distribution of the affected lots. We will provide clear instructions for the handling of the recalled product. We are in the process of informing the health authorities in all countries affected by this recall.
