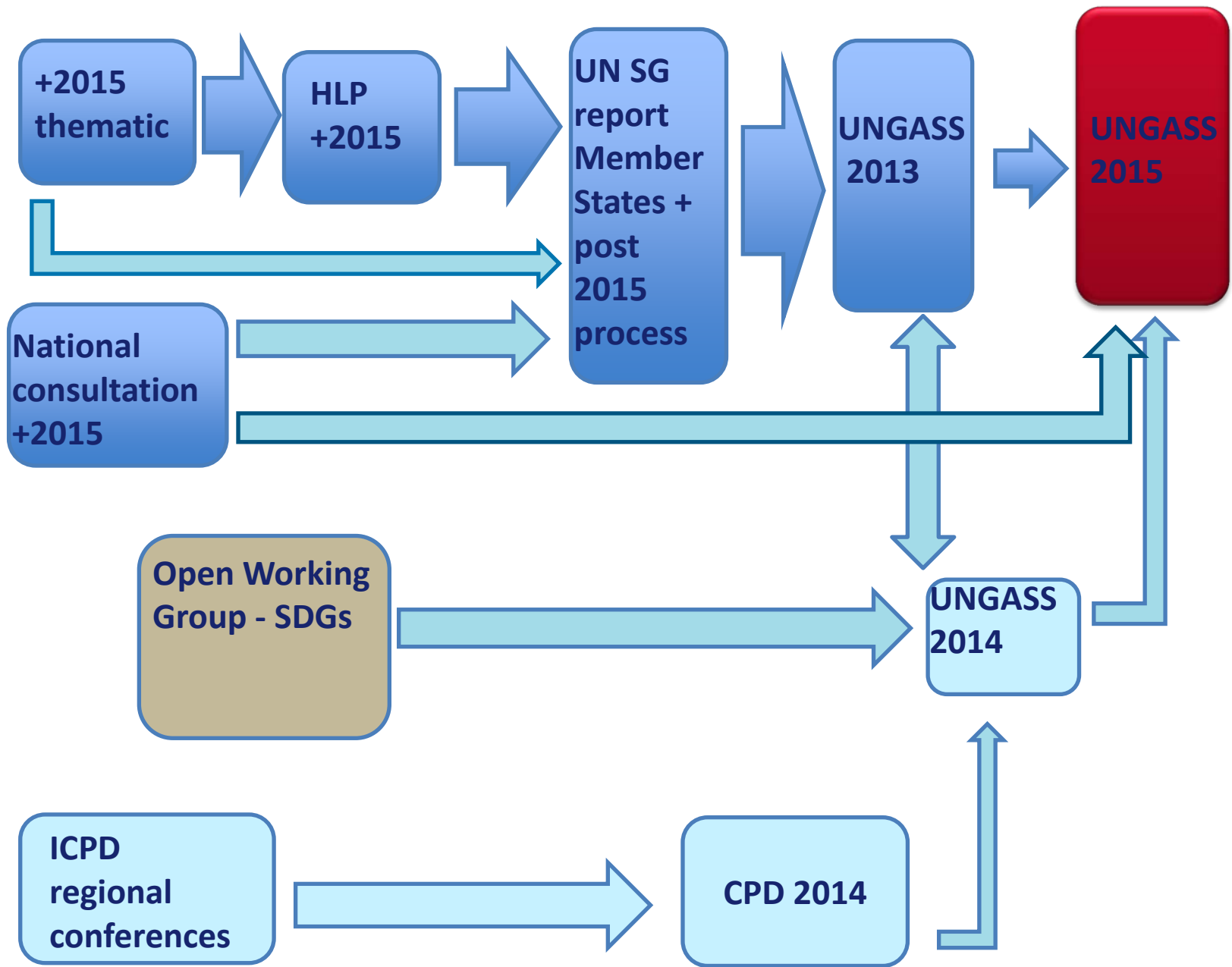
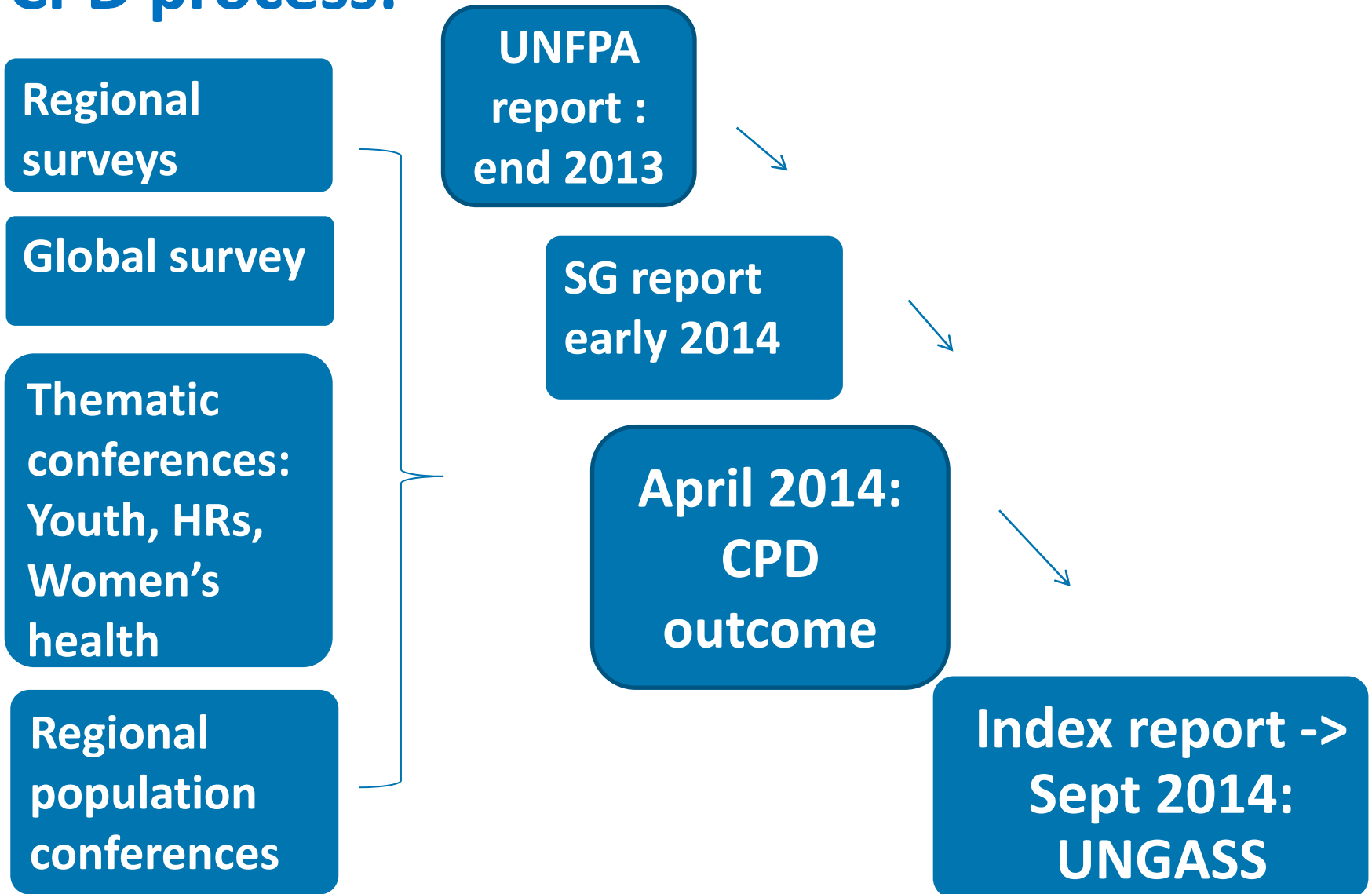


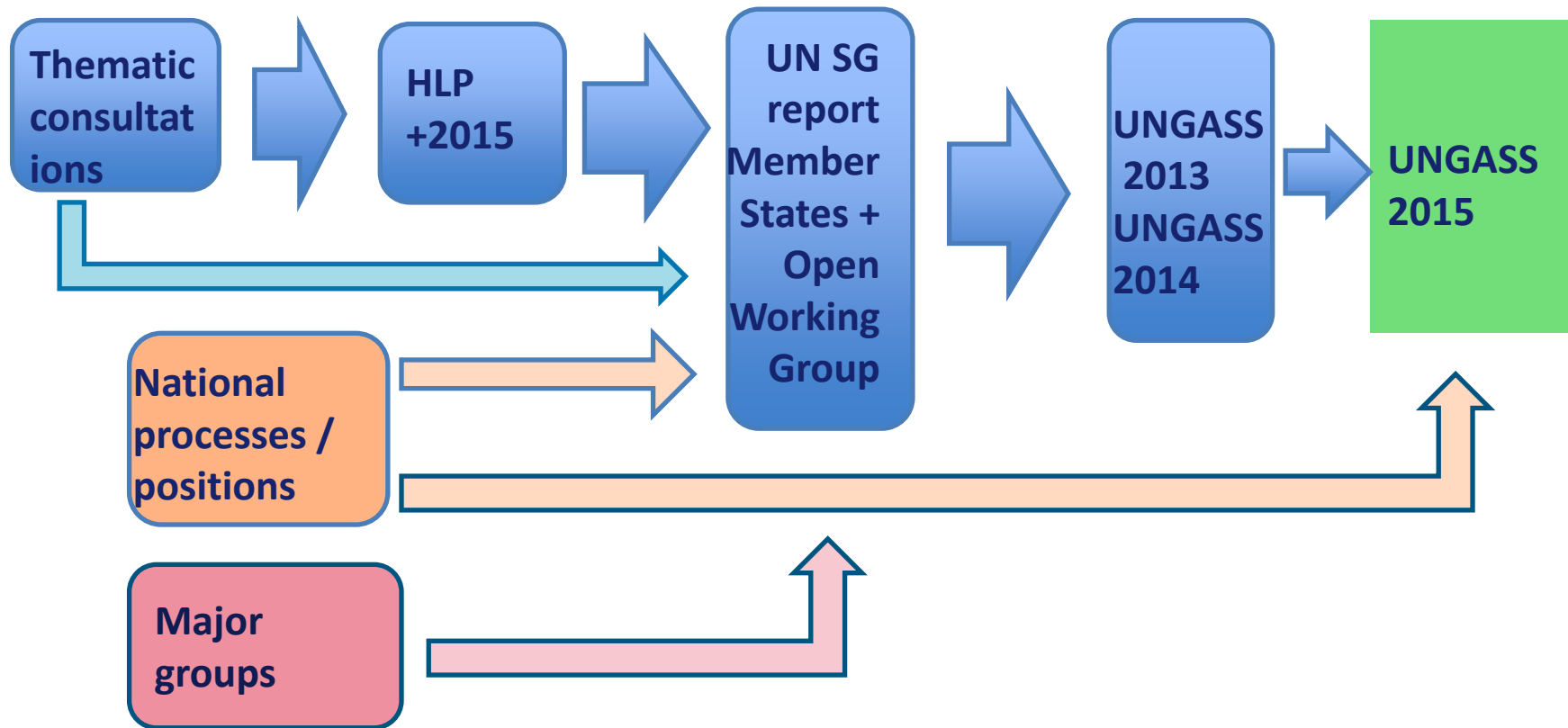

Post-2015 Process

- September 2013: UNGA Special Event: new 'modalities'
- OWG meetings to February -> report -> UNGA 2014

Sixth session; 9-13 December, 2013 – 5 DAYS

- Global partnership for achieving sustainable development (2 days)
- Needs of countries in special situations, African countries, LDCs, LLDCs, and SIDS + specific challenges facing the middle-income countries (2 days)
- Human rights, the right to development, global governance (1 day)

Eight session; 3-7 February, 2014 – 5 DAYS

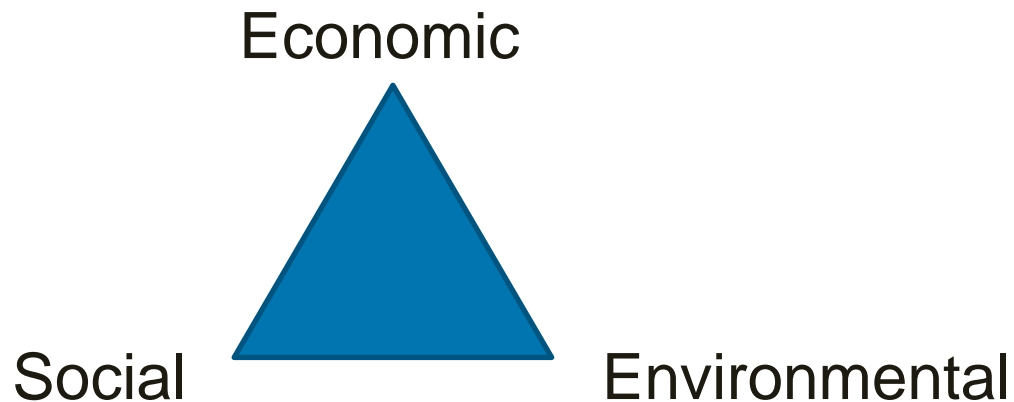
- Promoting equality, including social equity, gender equality and women's empowerment (1.5 days)
- Conflict prevention, post-conflict peace-building and the promotion of durable peace, rule of law and governance (1.5 days)
- September 2014 – UN General Assembly – CPD focus
- September 2015 – UN General Assembly – final framework
- 2015-2016: National target setting?

Our opportunities and challenges

- Strong CSO calls for SRHR, gender equality and women's empowerment
- Contacts with Women, Youth Major Groups
- UN Women, UNFPA, High Level Panel, some governments support gender equality and SRHR
- Secretary General's report 2013 mentions SRH and RR
- Post-2015 process ahead unclear
- Very crowded / competitive: lots of CSOs asking for lots of things
- Member States: many not prioritising RH (education, food, climate, peace & security...)
- Anticipate lot of pressure, trade-offs, regional factions, rush to bottom

To get traction our asks must be:

- Measurable (indicators using existing data)
- Tangible (targets that are understandable)
- Have broad political support
- Have a impact on 3 aspects of development:



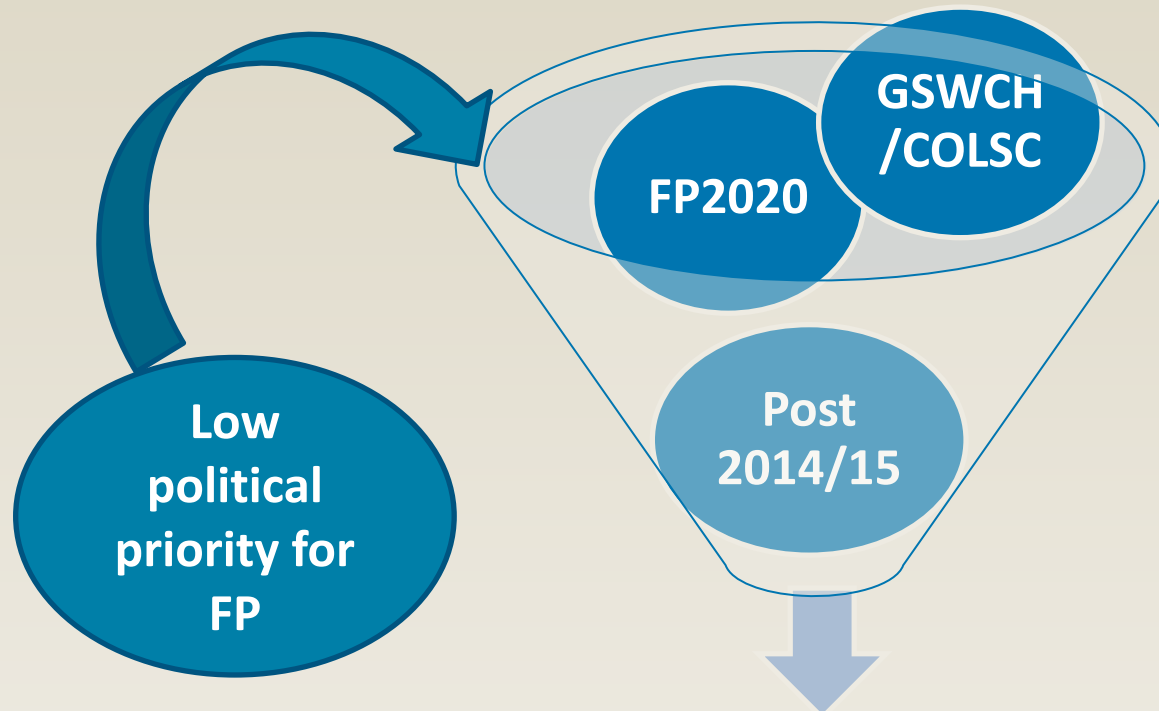
Measurable indicators for RH:

Use existing data – already collected:

- ? Unmet need
- ? Contraceptive Prevalence Rate (improved)
- ? DHS: unintended pregnancies 15-19 years
- ? Drop out rate from school due to pregnancy
- ? DHS: final say on decision-making on own health care
- ? Government spend % GDP on health / RH
- ? Others....

Unfinished business:

connecting CPD 2014, post-2015, FP2020, COLSC



What we want in the new framework:

Health goal: Universal health coverage and care

- Elimination of stock outs (MDG 8)
- Elimination of unmet need for FP (MDG5b)

What should we do?

Use 2 processes:

- Conference on Population and Development 2014
- Post-2015: OWG + new modalities

Target members states:

- Civil servants: MoH/women etc -> MoFA -> New York missions (must connect capital + negotiators)
- Parliamentarians: influence government positions
- Get the right people on delegations
- Ideally influence regional groups

What do we have: what do we need?

We have

- Evidence base
- Access: MoH -> national positions → MoFA & national negotiators
- Likely goals we can work with: Health, Gender...

Need

- Coherent plan: identified policy targets, messages / proposals for targets + indicators, modes of communication
