MEETING OUTCOMES

A meeting on new product introduction was held at the 2014 RHSC Annual Membership Meeting in Mexico City and was a valuable forum for sharing progress and lessons learned across a number of projects. In 2016, much progress has been made on the introduction of both new and underutilized technologies and there is consensus that a broader product introduction meeting would be beneficial for continued learning and sharing to overcome obstacles to introducing and scaling new methods. Specifically, the meeting will aim to address the following objectives:

- Share case studies on country-level product introduction for new and underutilized contraceptives highlighting best practices and successful solutions to overcoming common barriers.
- Discuss areas where programs and partners could work better together at the country level to create greater efficiency of resources.
- Discuss the creation of a community of practice around new contraceptive product introduction.

In April 2015, USAID started to regularly convene a Consultative Group for LNG-IUS introduction that includes fellow donors CIFF, BMGF and UNFPA, with the objective of building a prioritized learning agenda and coordinating a platform for introduction plans, training and regulatory resources. The Consultative Group goal is to facilitate access to high-quality, affordable LNG IUS products among low-income women in developing countries to increase the range of highly effective contraceptive options available to them within the context of informed choice. Panelists will describe their involvement in the Consultative Group and the moderator will lead a discussion about what is working well, and elicit feedback from the audience regarding lessons learned from other similar platforms.
