New report details steady decline in market value of FP supplies shipped to FP2020 countries

Analysis from the newly-published [2018 Family Planning Report](#) shows a steady decline in both the market value of FP commodities and overall CYPs shipped to the public and social sectors in the 69 FP2020 countries. 2017 figures were the lowest seen in seven years.

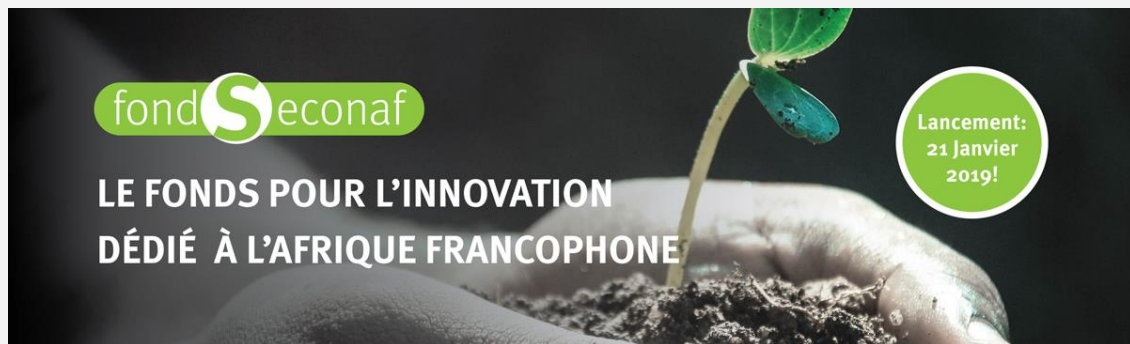
The report – jointly produced by the Clinton Health Access Initiative and the Reproductive Health Supplies Coalition – shows these market trends aligning with reported expenditure levels among the two largest institutional procurers of family planning products, USAID and UNFPA. Uncertainties over longer-term donor funding and growing funding gaps highlighted by the [2018 RHSC Global Contraceptive Commodity Gap Analysis](#) remain critical factors in determining the health of this market.
