New study examines entry of misoprostol and mifepristone into Argentina

Concept Foundation in partnership with CEDES Argentina, and with support from the RHSC, The study found that the lack of regulatory requirements for misoprostol and mifepristone products lengthened product development and registration times. It flagged the consequences of inaccurate demand forecasts and called upon Argentina's regulatory agency to issue import waivers for MA products registered in countries with stringent regulatory agencies. RHSC helps inform new WHO guidance on oxytocin

New [regulatory guidance](#) for the marketing of oxytocin, released by WHO and partners, references the RHSC's own [Advocacy Messaging Framework for Oxytocin](#) developed by the Maternal Health Supplies Caucus in 2018. Both resources reiterate the importance of keeping high-quality oxytocin at a low temperature to ensure its efficacy in treating postpartum hemorrhage.

COVID-related price hikes spur advocacy in Latin America

RHSC/ForoLAC-funded research has found that opportunistic oral contraceptive price hikes have led to increases of at least 10-20% in Peru, Chile, Colombia, and Uruguay. As 60% of contraceptive funding is out of pocket, the impact on individual consumers is an unwelcome reality, especially given the negative impact of COVID on household incomes. Four partner organisations -- PROMSEX Perú, Oriéntame Colombia, MYSU Uruguay and Corporación MILES de Chile – have designed an advocacy campaign to hold manufacturers accountable for excessive increases in these four countries. These factsheets were designed as advocacy tools to help decision makers budget, program, and distribute contraceptives in their countries.

WHO alert brings timely warning about falsified RH supplies

Suspicions of counterfeit misoprostol, falsely labeled as Cytotec, were reported to the World Health Organization (WHO) this summer. A thorough investigation confirmed that the product was indeed falsified and that it had reached the levels of wholesalers and patients in Cameroon, the Democratic Republic of Congo, Ghana, and Nigeria. The WHO has since issued a [Medical Product Alert](#), which has been distributed broadly. While we are all aware that counterfeit pharmaceuticals may exist in low- and middle-income countries (LMICs), we often downplay the risk, in part because we assume the profits to be gained would be relatively low. However, this incident reminds us that RH supplies are not immune to the threat of counterfeiting. This is especially true now during the COVID-19 pandemic; due to the myriad disruptions that are still occurring globally on so many levels, conditions are unfortunately ripe for the distribution of counterfeit and substandard health supplies in LMICs. And it is incumbent upon all of us to be vigilant and continue to actively ensure the integrity of RH supply chains.
