Public-private venture sees success in Chile Case study records win-win pricing situation in Chile

Read how Chile's innovative public-private procurement program has reduced drug prices and lowered out-of-pocket expenditures by enabling private pharmacies to purchase medicines through the national procurement agency, CENABAST. Nearly 200 pharmacies have participated to date, and results include price drops of more than

20 percent, with the Mirena hormonal IUD falling by 50 percent in price. A ForoLAC-produced case study examines the legislation enabling CENABAST to act as an intermediary procurement agent for the program which generates profits for manufacturers (through increased procurement volumes) and cost savings for consumers. Columbia University to showcase work on period tax

WASH United's [period tax website](#), developed with financial support from the RHSC, recently incorporated several key updates including new case studies on Namibia and Mexico, and a [Spanish-language](#) version of WASH United's groundbreaking [advocacy guide](#). The site's interactive map also shows that six countries have removed or reduced taxes on menstrual products in 2021. On 24 November, the RHSC and WASH United will host a [Spanish-language webinar](#) in which [Menstruación Digna México](#) will present how they campaigned successfully for the removal of the period tax in Mexico. Meanwhile, Columbia University has launched a free, [self-paced, e-learning course](#) on menstrual health and hygiene that incorporates WASH United's learnings on period tax.
